SUPERVISED VISITATION FEES

One of the ways in which forensic practitioners maintain neutrality and ethical practice is by assuring that fee payment is not contingent on a particular recommendation or outcome. As such fees are due as an advance retainer.

Fees & Retainer

Responsibility for fees (100% to one party, 50/50 split, or other arrangements) should be specifically addressed in the court order or agreement for services. Current fees are as follows:

Registration.....	\$50.00 per party
Basic staff supervision	\$65.00/hour
Administrative activity (orientation, correspondence, etc.).....	\$150.00/hour
Court testimony (per staff member, 3 hour minimum charge) ¹	\$250.00/hour

A retainer of \$200.00 is due in advance from **each** of the parties. If one party is ordered to pay for all costs of services, the retainer is \$400.00. Payments may be charged against the retainer provided that the parties continue to fully replenish the retainer when billed.

Payment should be made in the form of check or money order made out to “Forensic Counseling Services” or “FCS” and mailed to 2831 Eldorado Pkwy, Suite 103-377, Frisco, TX 75033. Returned checks will be charged the maximum fee allowable under law. If a party is late in replenishing the retainer or if the retainer ever falls below two hours of services supervised visitation may be suspended until such time as the retainer is replenished.

Fees for court appearances or deposition are due at least one week before the scheduled appearance. If an appearance request is received without a minimum of one week notice the appearance fee is due immediately and there will be an additional \$250.00 express charge. Failure to provide the fee as specified constitutes release from the requested appearance.

Please note: We encourage parents to avoid the cost of staff appearances by planning ahead to have records submitted via a business records affidavit. Our staff are not forensic evaluators and will not offer opinions regarding whether parent-child contact should continue to be supervised or not, or on the subjective quality of parent-child interactions. Any feedback offered during supervision is to address issues related to supervision. Our primary focus in this regard is on

compliance with supervision guidelines to insure the emotional and physical safety of the children involved.

Cost Multipliers for Personal Supervision by the Program Director

Dr. Robb is usually only available to provide supervised visits during his normal office hours, beginning at 9:00 a.m., and ending no later than 4:30 p.m., Monday through Thursday. We are generally closed on Fridays, weekends, government holidays, and Frisco ISD holidays.

The current base rate for supervision by the Program Director is \$250.00 per hour. For supervision or any additional administrative work by the Program Director outside of normal office hours, the following multipliers apply:

Timeframe	Multiplier
Weekdays after hours	x1.5 base rate
Weekends between 9:00 a.m. and 4:30 p.m.	x2 base rate
Weekends after 4:30 p.m.	x2.5 base rate
Holidays (national, state, or Frisco ISD closures)	x3 base rate

These multipliers are cumulative. For example, services requested after hours on a weekday holiday would incur a x4.5 multiplier, or \$1,125.00 per hour.
